WHEREAS, the Village of Kincaid's new fiscal year began May 1, 2023;
and

WHEREAS, Section 8-2-9 of the Illinois Municipal Code requires the
passage of an Annual Appropriation Ordinance within the first quarter of the
fiscal year (65 ILCS 5/8-2-9); and

WHEREAS, Section 8-1-7 of the Illinois Municipal Code permits the
Village Board to authorize the expenditure of funds pending the adoption of the
Annual Appropriation Ordinance (65 ILCS 5/8-1-7).


NOW THEREFORE, BE IT ORDAINED by the President and the

SECTION 1: Pending passage of the Annual Appropriation Ordinance, the

funds upon the basis of the Appropriation Ordinance for the fiscal year which
commenced May 1, 2023.
