AN ORDINANCE ESTABLISHING NEW WATER RATES FOR THE VILLAGE OF KINCAID, JEISEYVILLE, AND BULPITT, KINCAID, CHRISTIAN COUNTY, ILLINOIS

WHEREAS, the President and Village Board of Trustees for the VILLAGE OF KINCAID believe that it is in the best interest of the public health, safety, morals, and welfare of the residents of the VILLAGE OF KINCAID and those people who enter the territorial jurisdiction of the VILLAGE OF KINCAID to increase rates for water charges in the VILLAGE OF KINCAID and to increase water rates for Jeiseyville and Bulpitt.

NOW THEREFORE, BE IT ORDAINED by the President and the Village Board of Trustees of the VILLAGE OF KINCAID, Christian County, Illinois, as follows:

SECTION 1: Attached hereto as "Exhibit A," are the new increases in the water rates for the VILLAGE OF KINCAID. Said Exhibit A also includes the increase for water rates for the Village of Jeiseyville and Bulpitt. Said Exhibit B is attached hereto and fully incorporated herein as and for part of this Ordinance.

SECTION 2: The provisions of other VILLAGE OF KINCAID Ordinances, to the extent that they duplicate, conflict with, or otherwise affect the validity hereof, shall be disregarded, and otherwise, all of the provisions of all other VILLAGE OF KINCAID Ordinances shall remain in full force and effect.

SECTION 3: If any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision, or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

SECTION 4: This Ordinance shall become effective upon its passage, approval, adoption, and publication in pamphlet form as provided by law.
