## ORDINANCE NO. 906

## ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF KINCAID, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2023, AND ENDING APRIL 30, 2024

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF KINCAID, CHRISTIAN COUNTY, ILLINOIS:
