ORDINANCE NO. 957

THE ANNUAL TAX LEVY ORDINANCE OF THE VILLAGE OF KINCAID, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2023, AND ENDING APRIL 30, 2024

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF KINCAID, CHRISTIAN COUNTY, ILLINOIS:

SECTION 1: This Ordinance shall be known as "The Annual Tax Levy Ordinance of the Village of Kincaid, Illinois, for the fiscal year beginning May 1, 2023, and ending April 30, 2024."

SECTION 2: The following sums, or so much thereof as may be authorized by law, be and the same are levied and assessed on all of the real and personal property within the Village of Kincaid, Christian County, Illinois, subject to taxation as the same is valued for State and County purposes for the current fiscal year beginning May 1, 2023, and ending April 30, 2024, an appropriation having been heretofore made for all corporate purposes of the Village of Kincaid, Illinois, in the following amounts and for the particular objects and purposes set forth, as follows:

SECTION 3: The Village Clerk or her agent of the Village of Kincaid shall file with the County Clerk of Christian County, State of Illinois, a certified copy of this ordinance and said County Clerk shall ascertain the rate per centum which, upon the total value of all property subject to taxation within said district, at the full, fair cash value as the same is assessed and equalized by the Department of Revenue of the State of Illinois for state and county purposes for the current fiscal year ending April 30, 2023, will produce the net amounts herein levied and ordered certified, and she shall extend the tax upon the tax books of the collector of the State and County taxes within the said District as provided by law.

SECTION 4: If any part of this Ordinance is declared void or voidable or illegal by any Court of law, it shall not affect the validity of the remaining parts of this Ordinance.
