ORDINANCE DETERMINING THE AMOUNT OF MONEY ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION FOR THE FISCAL YEAR BEGINNING MAY 1, 2023, AND ENDING APRIL 30, 2024, UPON TAXABLE PROPERTY IN THE VILLAGE OF KINCAID.

WHEREAS, Section 4 of "The Truth in Taxation Act" requires the Village Board to determine annually the amount of money estimated to be necessary to be raised by taxation upon the taxable property in the Village's corporate limits;

Now, Therefore, Be It Ordained By The President And Board Of Trustees Of The Village Of Kincaid, Illinois:

Section 1: The Village Board of the Village of Kincaid, Illinois hereby determines that the amount of \$90,445.00 is estimated to be necessary to be raised by taxation for the fiscal year beginning May 1, 2023, and ending April 30, 2024, upon taxable property in the Village's corporate limits.

Section 2: This ordinance shall become effective upon its passage.
